- You agree to maintain strict confidentiality of your login credentials (email address and password) required to access the calculator and your account. You acknowledge and accept full responsibility for any access to the calculator or your account using your login credentials and agree to promptly inform us of any suspected or unauthorized access or use
- You understand and consent that the calculator and the account provided by SRPL-GROUP are made available in their current state, without any warranties, representations, or conditions, whether explicit or implicit. This includes but is not limited to, warranties, representations, or conditions of conformity, availability, quality, fitness for a specific purpose, non-infringement, absence of errors, or uninterrupted usage.
